DEPLOYMENT OPTIONS



Standalone Endpoints

Install, activate and manage BCWipe on standalone endpoints. Combine with a Server license to extend wiping capabilities to your network drives. Best for smaller teams.



Central Management

Deploy and manage BCWipe from a central console. Wipe files remotely without end-user intervention. Keep track of all wiping activities with extensive log files and reports. Best for large and medium teams.



Incident Response

Use BCWipe only when needed with a flexible Data Spills license. One license can be used on an unlimited number of endpoints over the course of a year, one endpoint at a time.

Best for data-spill cleanups.
